CHIEF RABBAN'S report



"Sing we joyous, all together," was the atmosphere in Montreal this past August when we attended the dedication of the new Shriners Hospital for Children.

The timing could not have been more appropriate as the first Shriners Hospital was opened in Atlanta Georgia September 01, 1915 consisting of two rented cottages in the suburbs. The hospital had 20 beds. The funding for this hospital was raised by the ladies of Scottish Rite Masons along with money from the Scottish Rite bodies. As a result the hospital was known as The Scottish Rite Hospital. Originally

the Shriner Hospital idea came from a resolution put forth by Morocco Temple of Jacksonville Florida which passed in 1902 to establish a tuberculin sanatorium.

The 1902 resolution was re-visited in 1919 at the Imperial Session in Indianapolis under Imperial Potentate of the day. It was re-worded to change the name to Shriners Hospitals for Crippled Children. One of the key persons behind this move was Phillip D. Gordon who had served many years as chairman of the Jurisprudence and Laws Committee and was undoubtedly a very powerful, respected man in the Order. Mr. Gordon was from Karnak Temple, Montreal! It was also resolved that a special assessment of \$1.00 be made on each member of the Order starting with the 1920 dues. As is the Shrine way, this was met with some reluctance but was eventually passed.

Following this a committee of seven was appointed to build a hospital for crippled children. For several days the committee met and decided to turn to the expertise of orthopaedic surgeons at several universities and they also talked with the Mayo brothers at their clinic in Rochester. Several sites were discussed but the honour finally went to Shreveport, Louisiana and the cornerstone was laid May 22, 1922. The first Shriners hospital, as we know

them, opened its' doors on September 16 that same year. It consisted of a remodelled house adjacent to The Masonic Temple. This was the beginning of our great philanthropy!

Prior to this, Shriners were known for their parades and frivolity. There were times when in excess of 200,000 Shriners virtually invaded a city for an Imperial Session. This is what we have to do again Nobles...we have to get the fun back into shrinedom. I don't mean chartering an airplane to go to an Imperial Session or North East Fall Field days, but let's try to get a few more individuals out to represent our Temple. The upcoming North East Fall Field days in Fredericton NB would be an ideal time to take the opportunity to see what it's all about. As we start having more fun, others will see it & want to know what we're doing and as a result MEMBERSHIP will increase. Become an active Shriner and enjoy what we've got, be proud of who you are. Lady Margaret & I have done a lot of travelling with our Temple over the past 10 years & feel that we have learned a lot about the organization. Now it's your turn.

Lady Margaret & I would like to wish you a healthy, happy holiday season & all the best in 2016.

Needless to say, these three projects have been and continue to be a significant part of the day - to - day routine in our house. In September, we held the 11th Annual Mazol Charity Golf Tournament at the Wilds in Salmonier. Other prize winners were Charlotte Hall of C.B.S. and Blair Reid of Bishop's Falls. Della chose a new Jeep Cherokee from the Hickman Group of Companies for her prize. Mazol enjoyed a very successful Fezeroo in 2015, with a final net contribution of \$66,000 to the PTF. I would like to thank the Nobles and Clubs, throughout Newfoundland and Labrador, for their continued support of this major fundraiser.

In December, Mazol presented the first of what we hope will become an annual event, "A Musical Christmas", at the D.F. Cook Recital Hall at Memorial University's School of Music. Planning for this event started in the spring and continued throughout 2015. I am indeed very thankful to the musicians and artists who found time in their busy seasonal schedules to work with us in making our first Christmas Concert a resounding success. Concurrent with the Concert planning, work began on producing a Shriner's Christmas CD, featuring a number of high profile local performers. We look forward to this CD becoming a significant revenue generator for the PTF, and we are considering an Irish-themed CD around the St. Patrick's Day celebrations.

Probably the high point for Lady Sharon and I this year was being in attendance at the opening of the new Shriner's Children's Hospital in Montreal. Following the Rocky Harbour Summer Ceremonial, we decided to do an Eastern U.S. driving vacation, culminating in a visit to Montreal for the new Hospital opening. What ensued was truly an exhilarating experience, as we joined approximately 2000 Shriners, their Ladies and special guests from across North America for this most memorable event. Nothing dampened the mood of the attendees that Thursday afternoon. While under a "big top" tent, we endured high winds and temperatures into the 30's. Even though it seemed that the tent might "lift-off" any minute, the crowd was not phased, as we enjoyed a musical celebration of talent from former patients who have gone on to major professional careers.

As a member of the Divan it is important to participate with the Potentate in his schedule of visits to the various Clubs across the Province. Lady Sharon and I greatly enjoyed our visits this year, especially the opportunity to build on the relationships we had started a year earlier. To effectively contribute to, and eventually lead the growth of Mazol, it is imperative to be part of these visits. Face to face contact enables a greater appreciation for regional issues and concerns. The year ahead will come with many new and exciting challenges for Lady Sharon and I, as I move into my new role as Assistant Rabban. But for now, as the Christmas Season is upon us, we wish to extend to all Nobles, Ladies and their extended families, a Very Merry Christmas and a Happy New Year.



No doubt economic pressures of younger families coupled with the necessity of a two person working family creates pressures and issues that has an overall effect on younger Masons joining us as Shriners.

The highlight of this year, without a doubt, was the official opening of the new SHRINERS HOSPITAL in Montreal. This is a state of the art facility that provides world class leading edge services to our patients. From a financial perspective we can hold our heads exceedingly high in knowing that we not only met but exceeded our financial goals in providing capital funds for the new hospital.

The Shriners Park in Eastport continues to provide the public with great awareness of Shriners in the Province. It not only provides a great services but in the years to come will provide a significant source of funding

through operational profits for the patient transportation fund. This could never have been accomplished without the dedication and commitments of Shriners involved with the park on an annual basis.

Christmas presents us with a season of reflection not only on the past year but on our overall lives. A time when family and those dear to us seem to matter more, a time when we express our thanks to almighty God for all the positive things in our life and the lives of our families. I'm reminded on a frequent basis of the words of another service organization of which Lady Shirley and I were members that stated; "To give with your heart is a great part of living, giving makes living a wonderful thing, taking the time to make someone smile goes a very long way to make living worthwhile". How relevant these words are to our great organization.

Lady Shirley and I take this opportunity to thank all Nobles and Ladies for the many well wishes and for great friendship during the year. We wish all Nobles and Ladies a happy and joyous Christmas Season and a very healthy and Happy New Year.

from the TREASURER'S desk



I would like to take this opportunity to bring you up to date with our financial results for the period to November 10, 2015

The Patient Transportation Fund had revenues of \$293,000 and incurred expenses of \$281,000 for a surplus of \$12,000. The revenues and expenses include the value of our

West Jet passes which amounted to \$62,000. This compares to 2015 annual budget revenues of \$254,000 and 2015 budgeted expenses of \$253,000 for a budgeted surplus of \$1,000

At our Summer Ceremonial we approved a donation to our Hospital of \$50,000. This gives us a deficit for the current year of \$38,000.

Our Temple had revenues of \$254,000 and expenses of \$227,000. Our budget for the year was for revenues of \$263,000 and expenses of \$264,000 for a shortfall of \$1,000.

Our Fezeroo made a profit of \$66,000 which was on budget unlike last year when we were \$32,000 short of budget. Fraternal donations are \$89,000 versus a budget of \$106,000. Expenses are within our approved budget. The loan to the RV Park is

down to \$76,761 and the loan to the Mazol Shrine Centre stands at \$40,000.







Jerry Gantt Elected Imperial Potentate of Shriners International



Imperial Sir Jerry G. Gantt was elected Imperial Potentate, part of the 13-member body that helps govern the Shriners fraternity, during the Shriners' 2015 Imperial Session – held in Houston July 5 - July 9. As Imperial Potentate, he is the highest-ranking Shriner in the world and serves as president of the Board of Directors of Shriners International, chairman of the Board of Directors of Shriners Hospitals for Children, and a member of the Board of Trustees of Shriners Hospitals for Children.

He is currently serving his 11th year as a member of the Board of Directors for Shriners International and Shriners Hospitals for Children.

The experience of both growing up in a small town and being a long-time resident of Houston, the largest city in the southern U.S., and Texas, has given Gantt the ability to adjust to surroundings and situations, and be comfortable and confident wherever he is. This adaptability will help him effectively guide and lead our two organizations, given their worldwide presence.

Years of Service

Gantt was raised a Master Mason at Cherryville Lodge #505 in 1971. He is a member of the York Rite, Grotto and was honored with the 33rd Degree of the Scottish Rite. He became a member of Oasis Shriners in Charlotte, N.C., in 1972, and joined Arabia Shriners in Houston in 1980, where he held numerous offices, including chairman of the Fiveyear Planning Committee. He served as the temple's Potentate in 2002.

Gantt is a chairman emeritus of Shriners Hospitals for Children — Houston Board of Governors and has served at the Imperial level as Outer Guard Aide, Captain of the Guard Aide, Imperial Marshal Aide and member of the Imperial Dispensations and Charters Committee. During his years as a member of the Boards of Directors, he has served on a number of committees, including Budget, Building and Equipment, Information Systems, Public Relations, Salary, Personnel and Retirement, Planning, Corporate Compliance, Education Seminars, Sports, Research, Medical Affairs, Strategic Planning, Investments and Budget. In addition, he has served as Liaison Officer to the Shriners Hospitals for Children in Philadelphia, Houston, Cincinnati, Montreal, Tampa, Honolulu and Galveston. In addition to his service in the Shriners fraternity, Gantt is an honorary member of the DeMolay Legion of Honor.

Personal Details and Perspectives

Born in Gastonia, N.C., Gantt attended Wingate College in Wingate, N.C. He then joined the United States Marine Corps., where he served as an air traffic controller. He is now President of Piedmont Contractors, Inc., a commercial general contracting firm in Houston.

At home, Gantt and his wife, Lisa, enjoy NASCAR and the Houston Livestock Show and Rodeo, where they are life-members and Gantt is an active committee member.

As Imperial Potentate, Gantt hopes to strengthen the relationship between headquarters' staff, the Boards of Governors, the national Joint Boards and the temple Divans. "We need to do some teambuilding, and remember we are all on the same team," he said.

To Gantt, his efforts on behalf of the fraternity and philanthropy are part of a much larger picture.

"Collectively – as Shriners – we make a difference in the lives of children every day – a much bigger difference than we could make individually," said Gantt.

"I am content to be a small part of such a big endeavor."



Introducing Our 2015-2016 National Patient Ambassadors

Every year, Shriners Hospitals for Children® selects two national patient ambassadors to represent the patients cared for by the health care system. The ambassadors spend the year sharing their stories, including the importance of Shriners Hospitals for Children.

Meet this year's National Patient Ambassadors:

Katharine Koonce, 11, of Huffman, Texas

In 2008, the Koonce family sought refuge from Hurricane Ike at the restaurant in Houston where Katharine's father, James, worked.

Suddenly, while 4-and-a-half-year-old Katharine slept, a fire broke out that quickly engulfed her room in smoke and flames. Katharine's father dove into the room and emerged with Katharine in his arms.

Both father and daughter sustained serious burns. Fifty percent of James' body had been burned and Katharine had burns covering 70 percent of her body. The two were airlifted to a hospital in San Antonio for emergency care.

Once stable, Katherine was taken to Shriners Hospitals for Children — Northern California, via a Medevac flight. After three long months of treatment there, Katharine returned to Texas and continued her rehabilitation at Shriners Hospitals for Children — Houston, and later, at the Shriners Hospital in Galveston.

Katharine is now 11 years old and is a happy, vivacious and busy child. She practices gymnastics, sings, plays piano and loves to dance. She also enjoys fishing with her father.

Katharine has dealt with this painful situation with grace and bravery. She has been an ambassador for her local Shriners Hospital in Galveston and is happy to now have the opportunity to share her story with others around the country.

"I love God, my parents and the Shriners because they have helped me a lot and they are like family," said Katharine.

Clint Crain, 15, of Huffman, Texas

The Crain family was out on their boat enjoying the 4th of July weekend in 2014, when tragedy struck.

While standing on the back of the boat, Clint lost his balance and fell right into the propeller.

Once the boat was stopped and Clint was able to swim to the surface, his mother jumped into the water and held Clint while she waited for Clint's father, who was in the water wakesurfing when Clint fell, to come help her.

Weather and the holiday weekend combined to cause delays in getting Clint to a hospital. Still, a surgeon was onsite and able to treat Clint, who was



in critical condition, when he arrived. After seven days in the hospital, including three in intensive care, and an above-the-knee amputation, Clint was sent to Shriners Hospitals for Children — Houston, where he received physical therapy weekly and was fitted with a prosthesis.

The Crain family believes that everything has worked out so well for Clint – possibly even miraculously – for a reason, and that perhaps Clint has a new purpose.

It has only been a year since the accident and Clint is doing remarkably well. He is a very positive and personable teenager and is a great speaker, and hopes to be able to give back to Shriners Hospitals for Children through the ambassadorship.

"It's the climb I'm taking to be who I was, and be even better than I was, because without them [Shriners Hospitals] I wouldn't be where I am, I wouldn't have the things I have, the confidence that I have," said Clint.

SUPPORTING TREATMENT AND RESEARCH OF OSTEOGENESIS IMPERFECTA









Imagine being a loving, devoted parent, but afraid to hug your child. Imagine being a child, and constantly being warned to "be careful; don't play too hard." Imagine always being aware that anything you might do – even just cough or sneeze – could break a bone.

For children and families living with osteogenesis imperfecta, these are daily realities.

UNDERSTANDING OSTEOGENESIS IMPERFECTA (OI)

In basic terms, the underlying cause of OI, also known as brittle bone disease, is a lack of collagen – or abnormal collagen – in the bones that prevents them from absorbing appropriate minerals and developing correctly. There are multiple types of OI – each with several symptoms and ranges of complexity and severity. In addition to the serious susceptibility to fractures, OI may cause below average height, early hearing loss, dental issues and additional orthopaedic difficulties, including bowed arms or legs, flat feet and scoliosis. Many children with OI will have difficulty walking.

For these children and their families everything – every activity, every choice, is measured against the threat of bone fracture, and other potential complications. The children and families coping with this debilitating disease will face it every day throughout their lives.

Shriners Hospitals for Children® has a long history of developing and improving available treatments for OI, and there is now more hope for these children and families than ever before. Still, research takes time, and the treatments are quite costly.

Over time, First Lady Lisa Gantt has become increasingly aware of the impact of OI on children and families, and is determined to make a difference. Her program, *In Dreams I Walk*, will provide additional funds to support Shriners Hospitals for Children's efforts in the treatment and research of OI.



My year so far has been another interesting and fulfilling one with the various events and happenings. As in previous years, it began with the Annual Installation Ceremony of our Illustrious Potentate, Sir Douglas Beattie and his Divan. This was followed by the Spring Outreach Clinic at the James Paton Memorial Hospital in Gander, then a very enjoyable Stated Meeting and Summer Ceremonial in Rocky Harbour. Later in August, I was privileged to attend the Dedication Ceremony of the new Shriners Canadian Hospital in Montreal. This was very rewarding.

Patient cases that come to my attention mostly are fairly straight forward. Nevertheless, they are always considered of utmost importance. During this past year, one particular occasion was more serious than most. I received a phone call from Noble Larry Moss telling me of the need for our specialized help for a young boy who had encountered a devastating situation in a skiing accident. Noble Moss is well acquainted with the father of this young boy, Wor. Bro. Phillip Hollett (and by

now Noble Hollett). Malcolm Hollett, a 14 year old young man, had sustained a serious spinal injury in a skiing accident in Clarenville. It was as a result of that phone call that I was able to obtain the help of St. John's Shrine Club's Patient Coordinator, Noble Sid Dyke and many others who assisted with helping Malcolm. I am delighted we were able to bring about a positive and rapid response that has led to a much happier outcome than was originally expected.

Outreach Clinic

This year's Fall Outreach Clinic was postponed due to it being a busy time for Montreal Hospital staff with the move of departments from the old Hospital to the New Shriners hospital. Dr. Fassier's demanding cases from Newfoundland and Labrador went to Montreal instead of the Gander Clinic with other appointments being rescheduled for the 2016 Spring Outreach Clinic.

On Oct. 31st2015, I attended the Fall Stated Meeting where I had the privilege of meeting 4 new nobles. My congratulations are extended to all of the new Nobles of Mazol Shripers.

Patient Statistics:

A total of 70 children with a total of 110 appointments were completed with 9 more pending, details are as follows: **Boston:** 1 Child – 2 appointments completed and 1 pending.

Philadelphia: 1 Child — 2 appointments completed.

Montreal/Gander: 68 Children with 97 appointments completed and 9 pending.

Total Patient Travel expenses so far this

year was \$252,881.52

- Philadelphia patient: \$87,500.00
- Labrador 2 patients at a cost approximately \$31,000.00.

The total cost would have been much higher if it were not for the 161 **West Jet Passes** that we have been fortunate to be able to use for 2015. This was valued at approximately **\$60,000**. The above figures also point out the value of the Outreach Clinic in Gander being able to keep our travel cost down.

Nobles, I am sure you can see, by the above figures, that at any time we could be called upon to "put our money where our mouth is". But having said that, despite the cost and hard work, our rewards come from the feeling we get when we look into the determined smiling face of a small child with special needs as well as the heartfelt thanks of parents or guardians of these special children. Nobles, it is there that we also see the profound gratitude that comes straight from their hearts for the work we do, in making their lives and living a little more comfortable. Nobles, if you want to experience That Feeling, then you should visit our Outreach Clinic or become a Patient Co-ordinator for your Club. In that way you will see first-hand the true reason for being a Shriner.

To all, as the Christmas Season draws nearer, Lady Mabel & I wish, for you and yours, that the Holidays and the coming year of 2016 will be filled with Safety, Peace, Joy, Hope, Good health and Prosperity.

MALCOLM'S JOURNEY



With thick auburn hair blowing in the wind and with no hint of trepidation, Malcolm was smiling when he finally boarded the air ambulance that would take him to Shriners' Hospital in Philadelphia . What lay ahead for him was uncertain. His hope was to recover from a recent serious back injury. Determination to do so would help fortify him for the challenges that he would face.

Concerns had been expressed earlier that the aircraft dispatched from Philadelphia might once again be delayed because of inclement weather . This was a particularly bitter cold wintry day in early March , 2015 . A chilling northeasterly wind swept across the bleak and snow covered airport at Torbay , Newfoundland . The gale force winds could easily buffet any aircraft and make landing difficult . It was hoped that the small plane expected to arrive soon would not have to turn back on this very important day of Malcolm's journey .

The ambulance which transported Malcolm from the Janeway Children's Hospital was parked near the tarmac. The medical attendants and Malcolm waited anxiously inside for the flight to arrive . There was a sigh of relief by all when the drone of engines was heard as the aircraft decended and landed safely . Malcolm was carefully transferred by stretcher through the leeward side door of the air ambulance. The assisting hospital staff from Philadelphia stayed onboard to attend to the patient during the long return flight . Seated by his side was his mom, Elizabeth .

It had been over a week since Malcolm took a horrific tumble while downhill skiing at the White Hills Ski Resort in Clarenville . He was taken to the nearby local hospital and later transported by ambulance to the Janeway Children's Hospital in St. John's where his condition was surgically stabilized . It was considered later , however , that more extensive rehabilitation treatment would be required to treat the injury to his spinal cord . Unfortunately the long term specialized hospital treatment needed was not available locally .

In the meantime Mazol Shriners had learned of Malcolm's

accident and contacted the family to offer their hospital support services . Shriners' Children's Hospital in Philadelphia had been specializing in the treatment of complex spinal cord injuries using stem cell transplantation and other therapy for a number of years . It's comprehensive program was considered to be the best spinal cord treatment currently available . Despair gave way to hope for the family . After careful review and medical consultation, Malcolm and his family decided that Philadelphia was the best option. The hospital paper work required for admittance was processed after which travel arangements were made. Malcolm thus became a Shriners' Hospital patient and if necessary will remain so until he reaches the age of twenty-one or until the family decides otherwise.

After six continuous months of treatment, Malcolm's rehabilitation in Philadelhia reached a plateau and his condition had improved to the extent that the doctors there decided that Malcolm's therapy could continue in St. John's. While hospitalized, Malcolm was exemplary to the other patients and often entertained both patients and staff by playing uplifting tunes on his guitar.

His return home in August was quite different than his departure had been on that harsh wintry day in early March. On arrival at the St. John's International Airport with his parents, after coping admirably with the ordeals of travel, he was joyously greeted and applauded by a large number of family and friends. He glowed with appreciation when he spied the large gathering. Awaiting him were baloons , welcoming banners , cameras flashing and a large, beautifully decorated cake that highlighted his name . It was all extremely impressive indeed and it was impossible for anyone present to avoid being emotionally stirred by the occasion . It was quite obvious that this happy looking young man was firmly resolute as he choose to walk down the arrival stairway towards the greeters rather than take the nearby elevator .

Throughout any given year various events unfold at all International Shrine Centers, including Mazol. Probably the most important event that could take place in any active Shrine Center would be the initiation of new members. Membership growth is essential if Shriners Hospitals are to continue to provide a high level of medical services to children in need. It is especially noteworthy to add at this point that during Mazol's Fall Ceremonial in October, Malcolm's dad, Bro. Phil Hollett, was ceremonially initiated and "fezzed in". Noble Hollett







was subsequently recognized not only for his commitment as a new Shriner but also received a standing ovation at the concluding dinner celebrations where he delivered a very moving account describing Malcolm 's journey and his own personal experiences .

On August 20, 2015, over 2000 people attended the Shriners Hospitals for Children®- Canada dedication ceremony and watched as Quebec Premier Philippe Couillard and Shriners Hospitals for Children® leadership cut a huge red ribbon officially opening the Montreal-based facility. Also present were Quebec Health and Social Services Minister Mr. Gaétan Barrette, M.D., Mr. Denis Coderre, Mayor of Montreal, , Mme.

Highly specialized pediatric orthopaedic care

The new hospital is modern, bright and spacious. The 207 000 sq. ft. facility allows the Shriners Hospitals for Children® - Canada to provide infants, children and young adults with state-of-the-art care and rehabilitation in a warm and friendly environment. It features a realm of new services and technologies



including 22 single-patient rooms, four surgical suites including one designed specifically for back surgery and a 200-seat education centre to enhance the teaching mandate as well as the care offered to current and future patients. The Shriners Hospitals for Children®-Canada provides full investigative, therapeutic and rehabilitation services on an inpatient and outpatient basis. The hospital treats patients in need of complex pediatric orthopaedic care for disorders such as osteogenesis imperfecta (brittle bone disease), scoliosis and spinal deformities. It also cares for patients with neuromuscular conditions such as cerebral palsy. In addition, the hospital's highly skilled health care providers help children with limb length discrepancies and those who need reconstructive hand or plastic surgery. Other areas of specialization include the treatment of metabolic and heritable bone, rheumatology and urology diseases.



The project was completed on time and on budget and was overseen by André Ibghy Architects Inc. and a construction committee composed of representatives of Shriners International and the Montreal hospital. The conventionally financed facility was built by SNC-Lavalin.

Home away from home

From the reception area to the recovery

room, the hospital sets new standards in pediatric orthopaedic care, surgery, research and teaching. The hospital includes numerous new features such as an ambulatory care infusion room in which children with osteogenesis imperfecta (brittle bone disease) can receive drugs intravenously and an operating room equipped with an O-arm surgical Imaging System for spine surgery. This system gives surgeons unprecedented two- and three-dimensional images of the patient's anatomy making the placement of surgical rods and screws more precise.

High tech with a human touch

The new hospital was designed with a deep understanding that it will be a home away from home for several of the children and families served. Many of them will have travelled from

across Canada, the northeastern U.S. and from around the world for treatment. The overarching objective was therefore to make the facility welcoming and friendly. To this end, each floor features the colours and attractions of a different region of Canada from the Atlantic to the Pacific to the Arctic. Whimsical touches are found throughout. In the reception area, iconic maple leafs float down from the ceiling. The inpatient rooms located on the fourth floor have a beach theme with huge murals of sand castles and lights shaped like portholes. Also on the fourth floor, the Child Life Department has an under-the-sea theme with a huge sea life mural and lights that look like bubbles lazily floating to the ceiling. The Child Life Department also features a classroom with a huge picture window and an impressive view of the Montreal skyline and Mount Royal. There is even an indoor zen garden bathed in light where parents can enjoy a few minutes of quiet respite. The building's interior design is bright and airy, with a generous amount of large windows and several skylights inviting natural light deep into the heart of the structure. Altogether, this creates a unique healing and caring

environment.

The six-floor building located on Decarie Boulevard punctuates the west end of the MUHC Glen site. The Canada Shriners Hospital is linked to the Montreal Children's Hospital on two floors, which will facilitate greater collaboration, operational efficiencies and ease of access for patients and families.

Welcoming patients in October

On October 5, 2015, the first patient will be greeted in the ambulatory clinic, which has been designed to resemble a hockey rink, with a scoreboard to direct patients to their exam room and red hockey goal lights hanging from the ceiling. The walls are adorned with over 750 donated hockey sticks and pucks. Between now and October 5, employees and physicians will get to know their new hospital as they receive training on new equipment and protocols, and start preparing the hospital to welcome the first patients and their families.

The hospital is nearly three times bigger than the Cedar Avenue building and as a consequence, the new Shriners Hospitals for Children® – Canada is in the process of recruiting and hiring 40 full-time nurses, nurse's aids, cleaners and other employees.

Generous Community Support

Thanks to the incredible support of the community, the Exceptional Care for Exceptional Kids capital campaigned raised \$130-millon (\$127-million for the hospital and \$3-million for the Francis Glorieux Chair in Pediatric Musculoskeletal Research). A huge thank you to the thousands of individuals and corporations who have made this hospital possible. Your generosity will allow our dedicated health care professionals to care to help our patients reach their full potential. Mazol Shriners total contribution to date is almost \$742,000 that includes the \$225,000 donation from the estate of Noble Jack and Lady Irene Williams. To exemplify these donations, 2 waiting rooms in the name of Noble Jack and Lady Irene has been created. In addition, there is a patient's room named after Mazol and the Boot & Long Range Shrine Clubs have a plaque indicating their long term financial committment.

For me, being a Shriner, is all about the children we see and the specialized care we provide for them. That is most special to me - most dear to my heart. They are OUR children.

I have been a Shriner since 1984 and I've been involved with patients since 2000 – 15 years, first as co-ordinator for the Gander Shrine Club and, for the last 11 years, as Patient Chairman for Mazol for all of Newfoundland and Labrador.

During that period of time, I was directly involved with patients. The Outreach Clinic in Newfoundland and Labrador moved from St. John's to the James Paton Memorial Hospital in Gander, it being a more central location for families to travel. There, while assisting with the Outreach Clinics, I became much more involved with the children and their families. The Outreach Clinics are held twice a year, usually in the spring and fall, at which time, up to 30+ appointments are made to be seen by our Montreal Orthopaedic specialist, Dr. Francois Fassier. In addition to orthopaedics, I have also witnessed great work and much success in the areas of spinal cord injury and ear implants.

Anyone being present for those clinics will tell you about the wonderful experience it is and how good it feels to be there with those special kids. The quote "No man stands so tall as when he stoops to help a child" is very evident. There are many stories I could tell from

my experiences as a Club Patient Coordinator and Mazol Patient Chairman. The stories are way too many to list here and no one story or situation was ever more important than the other to me. Watching young children's progress and the successes achieved from year to year through our specialized care, making their lives much more bearable and comfortable is something I will never forget. The determination and smiles on the children's faces and the kind handshakes from parents is no doubt beyond compare. This is the fuel that keeps me going, because the children's energy is contagious.

Receiving a request from a family asking if we could help their child always motivates me to continue our work. Just knowing that here is another child who, as Shriners, we may be able to make life more bearable always makes me feel good about being a Shriner. I always take the opportunity, if possible, to visit those seeking assistance and offer some optimism for the future. While there have been, for the most part, many great success stories for our children, unfortunately there is a small few that are beyond our medical expert's help. Fortunately those numbers are few. However, there is still some sadness in that not all cases can be successful. For some, only a miracle might be the answer. But at times, there are what seem to be miracles.

I feel proud and privileged to be part of this great Philanthropy, of helping these special children and I am thankful for the opportunity to meet so many wonderful people through the fellowship of Shrinedom. So, whether

you are a new Shriner or have been a Shriner for some time, please find out more about what we, and what you, can do for these children.

When the next Outreach Clinic is held in Gander in the spring of 2016, make an effort to come and see for yourself why you are a Shriner - that is why I am. It will make you proud and it will be one of the most gratifying and satisfying experiences you may ever have. Why not consider offering to be a Club Patient Co-ordinator in the future??

Why did I Become a Shriner? The reason is because I can relate to some of those children. I reflect on my own childhood each time I see one of our special children. I think "But for The Grace of God there go I". I was around 12 years old when I encountered a very debilitating condition of my own. I was told by medical professionals that I had contracted "Spinal Tuberculosis and that I would never walk again ". Thankfully they were wrong! It was later found to be a form of juvenile arthritis. I was able to overcome this incapacitation with the assistance of much physiotherapy (dancing lessons) and by my own determination and, with much encouragement and help, I was able to walk again.

I see that kind of determination in many of the children I meet. I know that they will become all that they can be or more - they will never quit. They just need our encouragement and our expert specialized help, which we have and can give. Our rewards will then be instantaneous by their wonderful, smiling, and determined faces.

ELECTION OF OFFICERS The Imperial Law Reads:

Section 325.10 Representatives

- (a) Single Ballot. Where a temple elects more than one Representative, all candidates must be balloted for on one written ballot.
- **(b)** Complete Ballot. Each member voting must vote only for the total number of Representative to be elected, otherwise his ballot cannot be counted as a vote.
- **(c) Majority Vote.** A majority vote of those present and voting is necessary to elect each Representative.
- **(d) Election.** Only those candidates who receive a majority vote shall be declared elected.
- (e) Successive Ballots. Successive written ballots must then be taken in the same number on other candidates until all representatives are elected.
- **(f) Highest Vote.** *If more candidates receive a majority vote than the number of representative to be elected, then those receiving the greatest number of votes shall be declared elected.*
- (g) Void Ballot. Blank ballots are not votes.

Section 325.11 Election Regulations

- (a) Electioneering. The printing, publication, circulating or distribution of resolutions, letters, telegrams, tickets, email or other devices, by a Noble, suggesting, recommmending, opposing or containing the names of proposed candidates for office in the temple is prohibited.
- (b) Violation. For any violation of (a), the Imperial Potentate may suspend any offending Noble, and he may declare the election of the officers void and order a new election.
- (c) Notice. At least one week prior to the annual meeting or any election the temple Recorder shall mail to each member a notice thereof containing this section.

APPOINTMENTS ARE FOR ONE YEAR ONLY

When a Potentate's term of office expires, all appointments made by him during his administration TERMINATE, according to the Imperial Code.

Such appointments include ALL appointed Officers, Potentate's Aides, members of Committees and their Chairman, Special appointees, Directors, Assistant Directors and all members of the Potentate's staff.

Some uniformed Nobles have mistakenly believed or assumed their appointments to be permanent, NOT SO! Each Potentate, when installed in office must make his own appointments, including six (6) officers of the Divan -1^{st} and 2^{nd} Ceremonial Masters, Director, Marshal, Captain of the Guard and Outer Guard.

The Potentate has the Power and authority under Imperial Shrine Law to replace every appointee; or he may, if he believes it to be in the best interest of the Temple, retain all appointees by reappointment.

Traditionally, for the sake of efficiency, many Nobles of demonstrated ability, are continued in office or appointment by reappointment. But that is at the will and pleasure of the incoming Potentate.

In no case is he, or can he be bound by his predecessor. By the same token, in no case can any Potentate bind his successor.

Courtesy requires that the Noble holding an appointive office, position or assignment tender his resignation to the incoming Potentate. If it is the will and pleasure of the incoming Potentate that the Noble is to continue in his office or position by reappointment, he will be notified by the Potentate to that effect.

Should any Noble not holding appointment by the current Potentate wear a Fez carrying any title such as "Aide" or any other designation, he does so in violation of the Code.

Some Nobles seek to perpetuate an appointment fictitiously by adding to the lettering on the Fez the year or years of their appointment. This is a violation the Imperial Law. The offenders may be uninformed: but "Ignorance of the law is no excuse."

DUTIES OF THE ORIENTAL GUIDE

- The Oriental Guide in conjunction with the High Priest and Prophet will share the liaison duties between Mazol Shrine Centre elected Divan and the Clubs and Units.
- Immediately after election at the Annual Meeting he will be responsible for obtaining clothing commonly known as Divan
- Dress.
- He will serve on the Membership Committee.
- He shall also perform the duties appropriate to his station and those assigned him by the Potentate. For the sake of continuity, the task assigned the Oriental Guide may very well follow him through the four progressive years on the Divan.
- He will attend and assist in the Installation Ceremonies of the Club Executives when required.
- He will be available and on Parade for Mazol Shrine Centre at all Ceremonial and Shrine Centres functions.
- Once elected to the Divan line, the new Oriental Guide, at his own expense, will be responsible to purchase clothing to comply with the standard Divan dress.



LRSC Rogers TV Bingo



Greetings to all from the Board of Directors and Patrons of the Shriners RV Unit. It is hard to believe that another summer season has come to an end. The park officially closed for the season on September 30th. As I write this report the process has begun to prepare the park for winter closure. We are still completing some upgrading on the older sites and hopefully will have many of them widened and upgraded to 50 amp service in time for the beginning of the 2016 tourist season.

The 2015 park season has been by far the busiest and most successful that we've had since we assumed ownership. Revenue from site occupancy will achieve an excess of \$230,000.00, an all time high for the

park. With other income derived from various means, including activities, fundraising, and concerts, total revenue should reach \$300,000.00 plus for the season. Thank you to all of our seasonal patrons and transients who continue to come back to our park year after year.

Over the past three years the park was faced with a number of areas which needed immediate attention, not the least was our Recreation Center which needed a complete overhaul and refurbishment. In addition electrical upgrades were needed and completed on many of the older sites. New water, sewerage and electrical lines were installed in the ground, and a number of cosmetic upgrades and beautification projects were

completed in many areas of the park, including new sods, plants and shrubs. I am pleased to report that most of this work has now being completed and all bills paid. This could not have been achieved without the financial support we received from Gander Shrine Club, The Boot Shrine Club and from the physical help received from our workaholic president Ill Noble Bert Avery, and Nobles Ev Green, George Joseph, and Dave Reeves. In addition the Board of Directors is most thankful to the many park patrons who were quick to come forward to help with many of the outdoor work projects which took place over the summer. We want to especially thank Paul Duggan, Joe Cox, Ray Blundell and others who stepped forward to assist. Your help is greatly appreciated.

In 2014, our Board of Directors approved the seasonal employment of an outside supervisor. Wayne Cross, since coming to us, has proven to be an invaluable asset to our park. His many skills as well as his manner and ability to get along with his peers and patrons has been quite noticeable and appreciated. Thank you Wayne for all that you are doing. In May of this year Wayne's wife Paula was hired as my assistant in the office. Wayne and Paula are both residents of Eastport and come to us as a valuable addition to our park.

Seasonal occupancy in the park this summer reached a total of 108, an all time high. Since the closing of the park for 2015, 9 Seasonal Patrons have given notice that they will not be returning in 2016. Since then 5 new seasonal site requests have been approved and deposits paid for 2016, and there is a

waiting list on hand for 6 additional seasonal sites.

In July it was decided by our board that the park should invest in a new AED Defibrillator. The purchase was completed at a cost of \$2,200.00. The unit was placed in the old cottage which



was diverted into a first aid station. Delaney's Ambulance Service in Glovertown kindly consented to send down two of their first responders to give those interested a crash course in first aid including CPR and the use of the AED Defibrillator. 22 members of the park attended and from all reports indicated that they were impressed with the purchase, training and setup of the first aid station.

Our recreation center was a beehive of activity again this summer. Our own Shriners Connection under the leadership of Doreen Noseworthy held music on Wednesday and Friday evenings. With an abundance of musical talent in the park over the season and the variety of entertainment on hand, the center was filled to capacity for most events. Sunday morning gospel services were a huge success as well. Thursday evenings saw the rec. center filled for the weekly game of cards. Thank you to Lady Shirley Avery and Lady Marion Cook for overseeing the card games and making them the success they were.

During the month of June the park hosted the Explorers RV Rally, the Terra Nova Masonic Lodge annual BBQ and the Park Shriners annual BBQ. In addition, our park board hosted the Gander Shrine Club and Ladies to a Steak and Lobster Meal, followed by a dance in the Recreation Centre. This event was held in recognition of the generous financial support given to

the park by the Gander Shrine Club over the years, in particular their decision to completely pay for the cost of major renovations to the Recreation Building. At their request the building has been appropriately named, "The Flyers Recreation Center." Thank you Gander Shriners for all your support.

While July was a terrible month weather wise, it did nothing to dampen the spirits and activities of the park. Transient visitors came in abundance and while not being able to get out of their trailers due to the inclement weather, it was not uncommon to hear music and laughter happening on the inside of many trailers and motor homes. As in past years this event was filled to

On August 6th. Bugs and Debbie Greene, local and well known musical entertainers performed a concert in the Recreation Center. They generously offered to do this concert with all the proceeds going to the new Shriners Children Hospital Medical Research Fund in Montreal. The concert was a sold out affair and netted a total of \$2,685.00. This was truly an act of kindness from a couple who support the cause of Shriners throughout our province and elsewhere.

On August 15th. Wayne Hounsell, a seasonal patron of the park once again completed a bike challenge to



the park. This year Wayne peddled his bike from Gander to the park and in doing so raised a total of \$4,450.00 which was donated to the Shriners Children Hospital Research Fund in Montreal. Thank you to Wayne and his good wife Joan for their kindness and generosity in doing this challenge again this year and for the tremendous result.

On August 22nd. yet another very successful fundraiser was held in the Recreation Center. This time it was performed by the Pennell Brothers, Ern and Don who were supported by their friend, Meryll Rogers. This too was a sellout and realized a net total of \$1,300.00 which was donated to the Shriners Children Hospital Research Fund in Montreal. Thank you guys. Your kindness is much appreciated.

On the weekend beginning September 3rd it was our pleasure to host the official visit of Ill Potentate Sir Doug Beattie, his Divan and Ladies. The weather was beautiful for the whole weekend and it was evident that they enjoyed their visit immensely. The weekend began with a meet and greet held in the Recreation Center on Friday evening. During this event it was the pleasure of our Park President, Ill Sir Bert Avery to present a beautiful framed picture on behalf of the Board



of Directors to Ill Potentate Sir Doug Beattie and Lady Olive. On Saturday morning the Divan and our Board of Directors gathered for a meeting, which was followed by a tour of the park led by our President Ill Sir Bert Avery, accompanied by a number of the park board. It certainly appeared that the members of the Divan were guite impressed with what they had



seen completed in the park over the past couple of years. On Saturday evening they attended the 4th Annual Walter Pinsent Concert and Silent Auction held at the Beaches Heritage Center. The concert and silent auction was a tremendous success again this year. The concert sold out and the auction offered a good variety of items for bidding. As a result of the efforts of Noble Walter and Lady Norma, the event raised a net total of \$7,399.95. Sunday morning the Divan members attended the Gospel Service in the park Recreation Center. Upon completion they said their good-byes and departed for their homes.

The final event for the season took place on September 19th. An end of season potluck meal was held in the Recreation Center with 64 patrons of the park in attendance. The official

closing of the park for 2015 took place on September 30th.

Since the park closed, staff have been busy with upgrading and improvements to the older section of the park. Underground maintenance to water pipes, electrical and sewerage lines is ongoing. In addition older sites are being widened and lengthened and a number of sites are being upgraded to 50 amp service from the present 30 amp. It is also hopeful that new lighting will be installed in the Recreation Center and paneling installed on the walls, as well as new flooring. This should be completed in time for the 2016 tourist season.

Early September the Board of Directors unanimously supported the purchase of a new all purpose backhoe tractor for the park. After checking with various dealerships it was decided that we purchase a new Mahindra light duty tractor with the necessary attachments. This addition would allow us to do a lot of work in the park which previously had to be completed by outside contracting at considerable cost. Since its arrival the



machine has already been put to work and is proving itself to be a welcome and timely addition to the park.



In closing I am pleased to report that the Harold W. Duffett Shriners R.V. Park is "Alive and Well." With seasonal sites up and transient numbers on the increase, the park was able to complete all that it set out to do in 2015. We are also happy to report the following donations; \$10,000.00 to Mazol Temple, and \$10,000.00 to the Shriners Children Hospital Research Fund in Montreal. In addition, we paid \$30,000.00 to the ACOA loan account and \$10,550.00 to the PTF loan account. The Board of Directors would like to thank all who contributed in any way in getting the park to the standard it is now enjoying. We're not finished yet, but with the support of Mazol, our Clubs, our Seasonal patrons and Transient guests, as well as our fundraisers, we remain very confident that Your Park will continue to be the choice of campers and tourists seeking rest, relaxation, fellowship and fun. Our President, Ill Sir Bert Avery, our executive officers, and board of directors would like to take this opportunity to wish all of our patrons, customers and supporters the very best for the remainder of 2015, and a happy, healthy and prosperous 2016.




